SECTION 1. That Chapter 59, Article VI, Sections 6100, 6200 and 6250 of the Oklahoma City Municipal Code 2020, are hereby amended to read as follows:

6200.2. District Use Regulations.

- A. Special standards for specific uses identified in Table 6200.1 as Special Exception (SE), Special Permit (SP) or Conditional (C) are found in Section 59-9350, Standards for Specific Uses.
- B. Table 6200.1 lists the uses allowed in the office and commercial districts.
- C. Unless allowed conditionally as annotated in Table 6200.1, the owner/operator of any property who wishes to serve or sell alcoholic beverages, as defined by State law and subject to State licensing requirements, for on-premises consumption as an accessory function of the primary use of the property, may apply for a Special Permit, subject to the following condition, provided that the primary use is permitted within the zoning district, and providing that the facility in which the alcoholic beverages are served or sold complies with the City’s building code requirements.

If food or beverages are consumed in an outdoor seating/activity area between the hours of 11:00 p.m. and 8:00 a.m., the outdoor seating/activity area shall be separated by a distance of at least 100 feet from the nearest abutting property line of a residential use. Distances shall be measured from the closet edge of the outdoor seating/activity area to the nearest abutting property line of the residential use.

6250.2 District Use Regulations.

- A. Special standards for specific uses identified in Table 6250.1 as Special Exception (SE), Special Permit (SP) or Conditional (C) are found in § 59-9350, Standards for Specific Uses.
- B. Table 6250.1 lists the uses allowed in the industrial districts.
- C. Unless allowed conditionally as annotated in Table 6250.1, the owner/operator of any property who wishes to serve or sell alcoholic beverages, as defined by State law and subject to State licensing requirements, for on-premises consumption as an accessory function of the primary use of the property, may apply for a Special Permit, subject to the following condition, providing that the primary use is permitted within the zoning district, and providing that the facility in which the alcoholic beverages are served or sold complies with the City's building code requirements.

If food or beverages are consumed in an outdoor seating/activity area between the hours of 11:00 p.m., and 8:00 a.m., the outdoor seating/activity area shall be separated by a distance of at least 100 feet from the nearest abutting property line of a residential use. Distances shall be measured from the closest edge of the outdoor seating/activity area to the nearest abutting property line of the residential use.

- D. Medical marijuana grower operations must be conducted and maintained in compliance with the license issued by the Oklahoma Medical Marijuana Authority and in compliance with Oklahoma law, including but not limited to all applicable statutes, rules and regulations.
- E. No medical marijuana grower operation shall be permitted or maintained unless there exists a valid license, issued by the Oklahoma Medical Marijuana Authority for the particular use at the particular location.
- F. A medical marijuana grower operation may not be located within 1,000 (one thousand) feet of a residential zoning district measured in a straight line between the nearest perimeter walls of the buildings housing growing operations and the nearest property line of the residential district. The separation required under this Section shall not be applied to limit the location of a medical marijuana grower operation for which a license was issued by the Oklahoma Medical Marijuana Authority prior to (the effective date of this ordinance).

9350.38.1.1 Medical Marijuana Processing: General (59-8350.9)

- A. All uses must be located inside an enclosed building.
- B. Drive-through windows and drive-through lanes are prohibited.
- C. A ventilation/air filtration system shall be utilized that prevents odor from being detectible at the boundaries of the lot within which the building housing the medical marijuana processing facility is located, except that if such use is located in a multiple-tenant building, the ventilation/air filtration system must prevent odor from being detectible outside the tenant space housing the use.
- D. An electronic security system and surveillance cameras shall be utilized.
- E. Medical marijuana processing facilities must be conducted and maintained in compliance with the license issued by the Oklahoma Medical Marijuana Authority and in compliance with Oklahoma law, including but not limited to all applicable statutes, rules and regulations.

A ventilation/air filtration system shall be utilized that prevents odor from being detectible at the boundaries of the lot within which the building housing the medical marijuana processing facility is located, except that if such use is located in a multiple-tenant building, the ventilation/air filtration system must prevent odor from being detectible outside the tenant space housing the use.
- D. An electronic security system and surveillance cameras shall be utilized.
- E. Medical marijuana processing facilities must be conducted and maintained in compliance with the license issued by the Oklahoma Medical Marijuana Authority and in compliance with Oklahoma law, including but not limited to all applicable statutes, rules and regulations.
- F. No medical marijuana processing facility shall be permitted or maintained unless there exists a valid license, issued by the Oklahoma Medical Marijuana Authority for the particular use at the particular location.

- E. No medical marijuana education facility shall be permitted or maintained unless there exists a valid license, issued by the Oklahoma Medical Marijuana Authority for the particular use at the particular location.

9350.49.2 Research Services: Medical Marijuana Research and Testing (59-8300.62.1)

- C. An electronic security system and surveillance cameras shall be utilized.
- D. Medical marijuana research and testing facilities must be conducted and maintained in compliance with the license issued by the Oklahoma Medical Marijuana Authority and in compliance with Oklahoma law, including but not limited to all applicable statutes, rules and regulations.
- E. No medical marijuana education facility shall be permitted or maintained unless there exists a valid license, issued by the Oklahoma Medical Marijuana Authority for the particular use at the particular location.

9350.54.1 *Retail Sales and Services: Medical Marijuana Dispensary (59-8300.63.1)*

- A. All uses must be located inside an enclosed building.
- B. Drive-through windows and drive-through lanes are prohibited.
- C. A ventilation/air filtration system shall be utilized that prevents odor from being detectible at the boundaries of the lot within which the building housing the medical marijuana processing facility is located, except that if such use is located in a multiple-tenant building, the ventilation/air filtration system must prevent odor from being detectible outside the tenant space housing the use.
- D. An electronic security system and surveillance cameras shall be utilized.
- E. Medical marijuana dispensaries must be conducted and maintained in compliance with the license issued by the Oklahoma Medical Marijuana Authority and in compliance with Oklahoma law, including but not limited to all applicable statutes, rules and regulations.
- F. No medical marijuana dispensary shall be permitted or maintained unless there exists a valid license, issued by the Oklahoma Medical Marijuana Authority for the particular use at the particular location.
- G. A medical marijuana dispensary may not be located within 1,000 feet of another medical marijuana dispensary measured in a straight line between the nearest perimeter walls of the buildings (or portion of the building, in the case of a multiple tenant building) occupied by the dispensaries. The separation required under this Section shall not be applied to limit the location of a medical marijuana dispensary for which a license was issued by the Oklahoma Medical Marijuana Authority prior to (the effective date of this ordinance).

9350.67.2 Wholesaling Storage & Distribution: Medical Marijuana (59-8350.15.1)

- A. All uses must be located inside an enclosed building.
- B. A ventilation/air filtration system shall be utilized that prevents odor from being detectible at the boundaries of the lot within which the building housing the medical marijuana is located, except that if such use is located in a multiple-tenant building, the ventilation/air filtration system must prevent odor from being detectible outside the tenant space housing the use.
- C. An electronic security system and surveillance cameras shall be utilized.
- D. Medical marijuana distribution facilities must be conducted and maintained in compliance with the license issued by the Oklahoma Medical Marijuana Authority and in compliance with Oklahoma law, including but not limited to all applicable statutes, rules and regulations.
- E. No medical marijuana distribution facility shall be permitted or maintained unless there exists a valid license, issued by the Oklahoma Medical Marijuana Authority for the particular use at the particular location.

B. Development Regulations. These regulations shall be implemented in addition to and in conjunction with the General Development Regulations of the Urban Design Overlay District pursuant to Section 59-13700.5. Where there is a conflict, these regulations shall take precedence over the development regulations of the underlying zoning district and the General Development Regulations of the Urban Design District, whether they are more or less restrictive.

(1) Use Regulations.

(a) Except as indicated in Table 13700.1 below, all uses permitted in the underlying zoning districts and the additional use of Multi-Family Residential (8200.12) are permitted within the Lincoln

Boulevard Corridor Subdistrict, subject to the applicable development standards and design guidelines of the Urban Design Overlay District and this subdistrict.
